1. The institute must have affiliation concerned State Board for the above courses before making admissions. In the absence of such affiliation this letter of approval shall be treated as withdrawn.

No Admission shall be made by the institution, Contrary to the guidelines is used by the AICTE for the academic session 2008-09. All the admission must necessary be made through entrance test.
